

MO-002b — Platform Deployment Duration Reduction

Statement

[Crucible](#) SHALL complete the selected [Platform Deployment](#) in less time than the approved [Deployment Baseline](#) under equivalent measurement conditions.

Derived From

This requirement derives from:

The Original Requirement states:

Crucible SHALL reduce platform deployment timelines from months to days or hours through automation.[C2]

MO-002b preserves the portion of the Original Requirement that requires a reduction in Platform Deployment duration.

The separate requirement derived from MO-002 addresses:

Assessment

The Original Requirement uses **reduce** without identifying:

- The approved Deployment Baseline
- The baseline Platform Deployment process
- The baseline Deployment Duration
- The Platform Deployment selected for comparison
- The activities included in each measurement
- The starting event
- The completion event
- The Controlled Inputs
- The operational context
- The measurement method
- The degree of required reduction

- The treatment of failed, incomplete, interrupted, or repeated deployments

The phrase **from months to days or hours** does not establish a controlled comparison because it does not identify a specific baseline duration or a specific measured duration.

MO-002b:

- Identifies the approved [Deployment Baseline](#) as the comparison point
- Identifies the selected [Platform Deployment](#) as the measured activity
- Requires the selected Platform Deployment to complete in less time than the approved Deployment Baseline
- Requires equivalent measurement conditions for the baseline and measured Platform Deployments
- Separates relative duration reduction from the maximum-duration obligation established by MO-002a
- Removes **through automation** because the phrase prescribes an implementation approach rather than the required outcome

Rationale

A claim that Crucible reduces Platform Deployment duration requires an approved and measurable comparison point.

The approved [Deployment Baseline](#) records the Platform Deployment process and duration used for comparison. The baseline and measured Platform Deployments require equivalent measurement conditions so that differences in scope, inputs, resources, environment, or measurement method do not produce a misleading duration comparison.

Equivalent measurement conditions include equivalent:

- Platform Deployment scope
- Controlled Inputs
- Starting event
- Completion event
- Included activities
- Operational context
- Computing resources
- Network conditions
- Measurement method
- Measurement precision
- Treatment of failed, incomplete, interrupted, and repeated deployments

The measured Platform Deployment satisfies this requirement when its Deployment Duration is less than the duration recorded by the approved Deployment Baseline under the applicable equivalent measurement conditions.

This requirement establishes a relative improvement over an approved Deployment Baseline. It does not establish the maximum permitted Deployment Duration. MO-002a establishes the absolute duration limit.

Verification

Verification confirms that:

9. The baseline and measured Platform Deployments use equivalent measurement methods
10. The measured Deployment Duration is less than the Deployment Duration recorded by the approved Deployment Baseline
11. Failed, incomplete, interrupted, and repeated deployments receive equivalent treatment in the baseline and measured results
