

MO-003a — Cross-Platform Deployment

Statement

[Crucible](#) SHALL deploy an [Infrastructure Environment](#) to two or more supported [Deployment Platforms](#).

Derived From

This requirement derives from:

- [MO-003 — Cloud-Agnostic Deployment](#)

The Original Requirement states:

The system SHALL provide cloud-agnostic deployment capabilities.[\[C3\]](#)

MO-003a preserves the portion of the Original Requirement that requires [Crucible](#) to perform deployment across multiple Deployment Platforms.

The separate requirements derived from MO-003 address:

- [MO-003b — Common Crucible Description](#)
- [MO-003c — Common Infrastructure Baseline](#)
- [MO-003d — Provider-Specific Dependency Limitation](#)

Assessment

The Original Requirement uses **provide** without identifying the behavior [Crucible](#) performs.

The phrase **deployment capabilities** does not identify:

- The subject deployed
- The target Deployment Platforms
- The minimum number of target Deployment Platforms
- The required deployment outcome
- The criteria used to determine whether a Deployment Platform is supported

MO-003a:

- Replaces **provide** with the direct action **deploy**
- Identifies [Crucible](#) as the responsible actor
- Identifies an [Infrastructure Environment](#) as the required deployment outcome

- Requires deployment to at least two supported Deployment Platforms
- Separates cross-platform deployment from common-input and provider-dependency requirements

Rationale

[Cloud Agnosticism](#) requires more than deployment to a single platform.

Deployment to two or more supported Deployment Platforms provides the minimum observable basis for evaluating whether Crucible performs cross-platform deployment.

A supported Deployment Platform has an available and approved mechanism through which Crucible performs the required deployment behavior. The applicable lower-level requirements define the provider contracts, provider implementations, platform-specific parameters, acceptance criteria, and deployment controls associated with each supported Deployment Platform.

Cross-platform deployment can include Deployment Platforms associated with:

- Commercial cloud providers
- Private cloud environments
- On-premises infrastructure
- Virtualized infrastructure
- Container platforms
- Edge environments
- Connected Environments
- Disconnected Environments
- Air-Gapped Environments

Deployment to multiple platforms does not alone establish full Cloud Agnosticism. The other requirements derived from MO-003 address common deployment inputs and limitation of provider-specific dependencies.

Verification

Verification confirms that:

1. Two or more supported Deployment Platforms are identified
2. Crucible performs an Infrastructure Deployment to each identified Deployment Platform
3. Each Infrastructure Deployment creates an Infrastructure Environment
4. Each resulting Infrastructure Environment satisfies the applicable deployment acceptance criteria
5. Each deployment result identifies the target Deployment Platform
6. Each deployment result identifies the applicable Provider Implementation
7. Each deployment preserves the required Evidence, Provenance, and Traceability

Verification includes:

- Supported Deployment Platform inspection
- Provider Contract inspection
- Provider Implementation inspection
- Cross-platform deployment tests
- Infrastructure Deployment tests
- Resulting Infrastructure Environment inspection
- Deployment acceptance-criteria evaluation
- Deployment-record inspection
- Evidence inspection
- Provenance inspection
- Traceability inspection

The verification record identifies:

1. Each tested Deployment Platform
2. The support status of each tested Deployment Platform
3. The Provider Contract applicable to each tested Deployment Platform
4. The Provider Implementation used for each tested Deployment Platform
5. The Controlled Inputs used for each deployment
6. The deployment result for each tested Deployment Platform
7. The resulting Infrastructure Environment for each deployment
8. The applicable acceptance criteria
9. The observed result
10. The generated Evidence
