Statement

[Crucible](#) SHALL use the same identified version of the provider-independent [Infrastructure Baseline](#) for each selected [Deployment Platform](#).

Derived From

This requirement derives from:

The Original Requirement states:

The system SHALL provide cloud-agnostic deployment capabilities.[\[C2\]](#)

MO-003c preserves the portion of the Original Requirement that requires common provider-independent infrastructure requirements across the selected Deployment Platforms.

The separate requirements derived from MO-003 address:

- [MO-003b — Provider-Independent Crucible Description](#)
- [MO-003d — Limitation of Provider-Specific Dependencies](#)

Rationale

A provider-independent [Infrastructure Baseline](#) establishes consistent infrastructure requirements across multiple Deployment Platforms.

Using the same identified version prevents a change of Deployment Platform from implicitly changing the provider-independent infrastructure requirements.

Provider-specific implementations may realize the same Infrastructure Baseline through different platform mechanisms. Those mechanisms do not change the requirements established by the identified Infrastructure Baseline.

Using the same identified version supports:

- Consistent infrastructure requirements

- Controlled comparison of deployment results
- Change control
- Detection of platform-specific changes to provider-independent baseline requirements
- Reuse across supported Deployment Platforms

This requirement does not require use of the same Crucible Description. MO-003b addresses that outcome.

Verification

Verification confirms that:

1. Two or more selected [Deployment Platforms](#) are identified
2. The provider-independent [Infrastructure Baseline](#) is identified
3. Each deployment uses an Infrastructure Baseline with the same identifier
4. Each deployment uses the same identified version of the Infrastructure Baseline
5. The Infrastructure Baseline contains provider-independent infrastructure requirements
6. Changing the selected Deployment Platform does not require modification of the identified Infrastructure Baseline version
7. [Platform Specific Information](#) remains separate from the provider-independent Infrastructure Baseline
8. Platform-specific implementation mechanisms do not alter the requirements established by the Infrastructure Baseline

9. Each deployment record identifies the Infrastructure Baseline identifier and version used for the selected Deployment Platform
10. The verification record preserves [Traceability](#) among the Infrastructure Baseline, selected Deployment Platform, Provider Implementation, platform-specific information, and deployment result

requirements and provider-specific implementation details.

- ☐ Determine whether changing the selected Deployment Platform may require any controlled transformation of the Infrastructure Baseline without creating a new Infrastructure Baseline version.
 - ☐ Define the identifier and versioning rules used to determine that each deployment uses the same Infrastructure Baseline.

- Use of the same identified Infrastructure Baseline version across the selected Deployment Platforms
- Separation of provider-independent baseline requirements and provider-specific implementation details

The unresolved boundary between provider-independent and provider-specific information should remain recorded in the Issues section until a controlling source defines it.

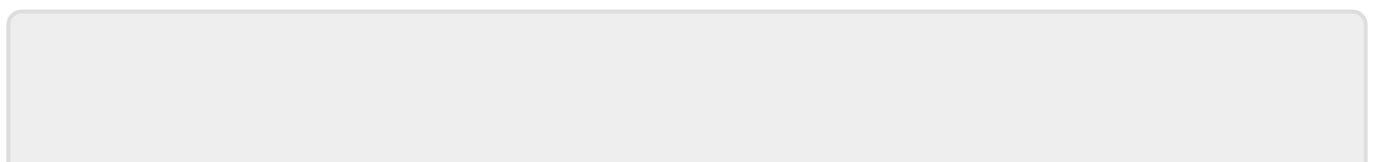
