

MO-005e — Infrastructure Baseline Reuse

Statement

Crucible SHALL apply the same approved [Infrastructure Baseline](#) revision to two or more [Infrastructure Deployments](#).

Derived From

This requirement derives from:

- [MO-005 — Reusable and Version-Controlled Infrastructure Baselines](#)

The Original Requirement states:

The system SHALL establish infrastructure as a reusable and version-controlled asset.[\[C1\]](#)

MO-005e preserves the reuse intent of the Original Requirement by requiring **Crucible** to apply the same approved Infrastructure Baseline revision to multiple Infrastructure Deployments.

The separate requirements derived from MO-005 address:

Rationale

Reuse occurs when **Crucible** applies the same approved Infrastructure Baseline revision to more than one Infrastructure Deployment.

The minimum threshold of two Infrastructure Deployments distinguishes demonstrated reuse from a single application of an Infrastructure Baseline revision.

Reuse supports:

- Consistent infrastructure composition
- Reduction of duplicated configuration effort
- Repeatable deployment processes
- Comparison of Infrastructure Deployments created from the same Infrastructure Baseline

revision

- Reproduction of previously deployed infrastructure
- Controlled deployment across multiple operational environments
- Controlled deployment across multiple Deployment Platforms
- Preservation of approved infrastructure configurations
- Preservation of [Provenance](#)
- Maintenance of [Traceability](#)

The Infrastructure Deployments may differ in deployment instance, location, operational environment, Deployment Platform, execution time, or intended use, provided that Crucible applies the same approved Infrastructure Baseline revision.

The resulting Infrastructure Environments need not be identical when permitted deployment-specific parameters or Provider Implementations produce controlled differences.

This requirement does not permit modification of the approved Infrastructure Baseline revision during reuse. MO-005f addresses preservation of approved revisions.

This requirement does not define the deployment record that identifies the applied Infrastructure Baseline revision. MO-005g addresses that Traceability.

Verification

Verification confirms that:

1. The approved [Infrastructure Baseline](#) revision is identified
2. Two or more [Infrastructure Deployments](#) are identified

3. [Crucible](#) applies the same approved Infrastructure Baseline revision to each identified Infrastructure Deployment
4. The Infrastructure Baseline Artifact identifier is the same for each identified Infrastructure Deployment
5. The Infrastructure Baseline revision identifier is the same for each identified Infrastructure Deployment
6. The approved Infrastructure Baseline content remains unchanged across the identified Infrastructure Deployments
7. Each Infrastructure Deployment completes with an identified result
8. Each permitted difference among the Infrastructure Deployments is attributable to identified deployment-specific parameters or Provider Implementations
9. The verification record preserves [Traceability](#) among the approved Infrastructure Baseline revision, each Infrastructure Deployment, the deployment-specific parameters, the Provider Implementation, and the deployment result

 - ☐ Define the criteria used to determine that two Infrastructure Deployments apply the same Infrastructure Baseline revision.
 - ☐ Define the deployment-specific parameters that may differ without changing the reused Infrastructure Baseline revision.
 - ☐ Define the permitted differences among Infrastructure Environments produced from the same approved Infrastructure Baseline revision.
 - ☐ Define whether reuse across different Deployment Platforms or operational environments requires additional equivalence criteria.

- The application result
- The associated [Provenance](#)
- The associated [Traceability](#)
