A [Test Environment](#) requires explicit and controlled descriptive information before a conforming realization deploys, operates, reproduces, or evaluates it.

The leaf requirements in this group establish the information required to describe the purpose, composition, relationships, [Configuration](#), [Constraints](#), versions, and [Baseline](#) associated with a Test Environment.

Separating these obligations supports precise determination of which information is complete, missing, inapplicable, or nonconforming.
